- Under 18 for campers
- Adult for leaders (Includes speaker, band & Rec Team)

Riverbend Retreat Center Legal Requirements

Medications

- No medication of any kind may be kept by any attendee during camp.
 - Original container with prescription label
 - Exception inhalers & epipens
- Need to be secure
- System for dispensing and logging.

Riverbend Retreat Center Legal Requirements

Bound Medical Log

State legal definition:

A bound medical log, or other unalterable record keeping system, listing date, name of patient, ailment, name of the Camp Health Officer, and the treatment prescribed shall be kept in the first aid are for the duration of the camp year for which the license is issued.

Riverbend Retreat Center Camper Injury

Non-Life Threating

- 1.Get camper to safe area
- 2.Immediately assess the severity of the injury and determine if camper is responsive.
- 3.Call Office to get CHO
- 4. Continue to care for camper until CHO or hirer medical authority instructs you otherwise
- 5.Only CHO or adult camp leader are to call 911 (again, this is for Non-Life Threatening injuries)
- 6. Notify office if 911 is called
- 7.Office will assign someone to go to gate
- 8. Office to contact Executive Director about situation

Riverbend Retreat Center Camper Injury

Life Threatening: This includes camper is unconscious (and Not Responding), seizers, uncontrollable bleeding or trauma that could result in death

- 1. Get camper to safe area
- 2. Immediately assess the severity of the injury. If the camper has experienced a life threating injury, the Summer Staff Leader or staff trained in first aid takes control and begins rendering aid to camper.
 - Instruct someone at the scene to call 911 (If no one at the scene can call 911, radio the office and instruct them to call 911 and give your location)
 - 2. Instruct staff to contact CHO and Office and inform them there is a code red at your location.
- 3. Continue first aid process until CHO or hirer medical authority instructs you otherwise
- 4. Office will assign someone to go to gate
- 5. Office to contact Executive Director about situation
